 - b. Dan Kipen (SAFD Rep): Picked up in Jan 2024 in call volume (45 total). Still working on the Year End Report. 51 calls in Monterey 2023.
 - c. Bob Geneski (County Clerk): Discussed 2022 Annual Report.
 - d. Scott Beltman (Commissioner): Pat Peterson as Vice Chair for Allegan GOP. In process of new Health Officer. Broadband update Monterey to be done by end of 12/31/24 and discussion of dissolving the workgroup. Remodeling began at Dumont Lake building to be completed no later than 12/31/24.
