The 2020-21 budget has \$67,000 in committed funds GL number 101-872-998to be used for:

\$40,000 for new fire equipment and \$27,000 used for unforeseen projects and emergencies, Fire department support, cemetery tree removal and plotting (physical and digital), roof repairs. Any additional commitments /or needed expenditures of these committed funds will be approved with board motion as specific projects for coming fiscal years are identified.

This Public Hearing fulfills the requirements of the Truth & Taxation law.

2020 Taxable Value - \$88,541,342

2020 Operating Millage Rate: .8092 mills x - \$88,541,342–which would yield in 2020 not more than \$ 71,648 Allocated Operating Tax, subject to the Headlee Amendment

2020 Extra Voted Renewed Road Millage Rate: 4.8686 mills x - \$88,541,342– which would yield in 2020 not more than \$431,073 Road Tax, subject to the Headlee Amendment.

The 2020-21 Budget includes the following: Levying a 1% administration fee on property taxes Levying a 3% penalty fee on property taxes paid after February 14 Levying a \$25.00 per residence recycling fee on the winter tax bill

Frank moved supported by L Commons to levy not more than 4.8686 mills for Roads for the tax year of 2020-21. Motion carried.

Frank moved supported by Collier to approve and appropriate at the department level the 2020-21 budget in the following amounts: General fund: \$502,630 Road fund: \$406,500 Building Permit fund: \$35,000 Cemetery fund: \$25 Motion carried, 5 yays, 0 nays
