2022 Extra Voted Renewed Road Millage Rate: 4.9286 mills x - \$101,206,515 – which would yield in 2021 not more than \$498,806.43 Road Tax,

subject to the Headlee Amendment.

Levying a 3% penalty fee on property taxes paid after February 14
Levying a \$50.00 per residence voted recycling tax on the winter tax bill
